Americans cannot afford college, so we can't produce doctors, nurses, teachers, engineers, etc. Emergency Rooms are -- therefore -- short staffed:

Mr. Trump, you had a GOP House, a GOP Senate, and YOU claimed to be a Conservative, yet you didn't keep your word here, when you had a chance, to cut these student loan originations -- as FORBES even quotes you -- and as I reference repeatedly in my letters to the editor to THE TIMES and THE LEDGERm for starters!!

You didn't do like former Pres. Obama: Whatever you think of "ObamaCare," the ACA, he rammed it through Congress when Democrats held a majority in both houses. You -- by contrast -- did NOT keep your word, Mr. President, as I document in my 3 attached letters to the editor, and I am very mad!!

However, Mr. Trump, I am a Conservative Christian FIRST, and THEN an "Angry Hornet" Republican, and will try to show you genuine Christian love, as Jesus asks us to follow His example (John 13:15, 1 Peter 2:21, Hebrews 2:14-18, showing He's not just Saviour, but also the ONLY perfect role model and example).

While I can't necessarily promise a total and complete endorsement of you and Rep. Laurel Lee, R-FL-15, my Member of Congress, I will give you... fair consideration, if you and Mrs. Lee do the following three (3) things:

- <u>1)</u> First, both of you should *probably* publicly apologize for failing to even TRY to cut pork, and then, she should file a bill to cut the largest discretionary pork spending in the budget, student loan originations (which were never needed, and not used at all until recently due to Swamp Higher Education lobbyists), and also Rep. Massey's HR899 to eliminate the Dept. of Education.
- <u>2)</u> Wait, you couldn't even get this done when you had a GOP House, GOP Senate, and you were a GOP president in your first 2 years, so why not? Either [[a]] you're a Liberal RINO, and still a closet Democrat, or [[b]] you're trying, but need help. If [[a]], please consider dropping out and backing Robert F. Kennedy, Jr. But, if you want my vote, try this strategy: Ask Congresswoman Lee (R-FL-15), Higher Ed/Workforce Chairwoman, Dr. Virginia Foxx (R-NC-05), Sen. Chuck Schumer (D-NY) and other lawmakers to file AND PASS student loan bankruptcy legislation (many good bipartisan bills exist), and this will [[C]] force down irresponsibly excess lending by Liberal Swamp Dept. of Education, saving trillions, but -- most importantly -- [[D]] force Swamp Higher Education lobbyists to BACK OFF lawn when they see the handwriting on the wall, thereby making originations spending cuts (maybe DOE elimination?) "politically viable."

Translation: You must do #2, above FIRST if you want to have any hope of doing #1. (If you disagree, please explain why you didn't do this IN YOUR FIRST TERM? Probably because ytou lacked bankruptcy as a Conservative Free Market "check" on lending excesses ...and lobbyist activities.)

<u>3)</u> Then, probably use your "Bully Pulpit" to direct the lawmakers to "direct fund" college (like we do with Public Education), and put colleges on a "strict diet," thus saving trillions, and the extra monies saved could be used to fund a strong Southern Border wall, and make needed upgrades to our fragile power and telecommunications grid.

If you don't do this (get your RINOS in line and back to Conservative values, ok?), then I will plow full steam ahead and stop at nothing to ensure voters know you and President Biden are tax/spend Liberals, and ensure a best effort to Primary Congresswoman Lee. And she's not even the worst: Congressman Scott Franklin, R-FL-18, who was my member of Congress before redistricting not only refused to attempt such cuts to Liberal pork spending, but is very disrespect to student borrowers, blaming them instead of "manning up," and cutting the spending himself.

Students have actually more than repaid taxpayers, and this even at illegally inflated levels of tuition inflation, and taxpayers have made BILLIONS in profits off students, but this will NOT keep up if we don't end the "Epic Fail" student lending system: If you don't do as I say (and get help from RINOS and DEMOCRATS... or am I being redundant?), ... we WILL hemorrhage and bleed-out, and crash the dollar, collapse our economy, and devolve and descend into Civil Chaos... because of you. And do-nothing lawmakers.

You can ignore me if you like, but only 2 things "under heaven" will force down lending excesses in lending: Either a VERY unlikely miracle... or the reinstatement, return, and restoration of Constitutionally-protected bankruptcy uniformity (Art.I Sec.8 Cl.4, US CONSTITUTION'S BANKRUPTCY UNIFORMITY CLAUSE), and which is also required by the golden rule of SEVERAL religions [JUDAISM: Leviticus 19:18b, Leviticus 19:34, The Golden Rule, OLD TESTAMENT (PENTATEUCH); CHRISTIANITY: Matthew 22:39b, Mark 12:31b, Luke 6:31, Matthew 7:12, The Golden Rule, NEW TESTAMENT (HOLY BIBLE); ISLAM: Surah 24:22 An-Nur, The Light, on treatment; Surah 2:275 Al-Baqarah, The Cow, on prohibitions of usurious interest; See also: Surah 3:130, The Family of Imran; Surah 4:161, The Women; Surah 30:39 al-Rum aka The Romans (THE NOBLE QUR'AN)].

Not only would you be violating the US CONSTITUTION, and getting "sideways with God Almighty," if you decide to be a "bankruptcy self-defense for me, but not for thee oh poor student" hypocrite, Mr. Trump, and nor only might this alienate Liberal and Independent voters you need, but -- most important, I think -- this would potentially angry Conservative voters like me when you refuse to keep your word to cut this spending that you had a chance to do in your 1st two years, when the GOP enjoyed control of both Houses and the Oval Office.
